WHEREAS, bids were received from four (4) vendors and publicly opened on February 15, 2017 with the results as set forth in the Attachment;

WHEREAS, a copy of each of the bids are on file in the office of the Business Administrator; and

WHEREAS, the Board has determined that based on the submitted bids that Student Transportation of America is the lowest responsive and responsible bidder for certain of the routes bid as set forth in the Attachment; and

WHEREAS, the Board has further determined that Lenoir's Transportation is the lowest responsive and responsible bidder for certain of the routes bid as set forth in the Attachment; and

WHEREAS, the Board has further determined that Aristocrat Limousine & Bus Company is the lowest responsive and responsible bidder for certain of the routes bid as set forth in the Attachment; and

NOW THEREFORE BE IT Resolved, upon the recommendation of the Superintendent and School Business Administrator, that the Parsippany-Troy Hills Board of Education hereby awards a contract to Student Transportation of America, 65 Route 46 East, Pine Brook, New Jersey 07058, to provide transportation for the routes indicated in the Attachment for which it was the lowest responsible bidder in the amounts set in the bid specifications and response in an amount not to exceed \$19,620; and

BE IT FURTHER Resolved, upon the recommendation of the Superintendent and School Business Administrator, that the Parsippany-Troy Hills Board of Education hereby awards a contract to Lenoir's Transportation & Charter Service, 15 First Street, Bloomington, New Jersey 07403, to provide transportation for the routes indicated in the Attachment for which it was the lowest responsible bidder in the amounts set in the bid specifications and response in an amount not to exceed \$15,360; and

BE IT FURTHER Resolved, upon the recommendation of the Superintendent and School Business Administrator, that the Parsippany-Troy Hills Board of Education hereby awards a contract to Aristocrat Limousine & Bus Company, 354 Kingston Road, Parsippany, New Jersey 07054, to provide transportation for the routes indicated in the Attachment for which it was the lowest responsible bidder in the amount set in the bid specifications and response in an amount not to exceed \$10,000; and

RESOLVED, that the Parsippany Troy-Hills Board of Education authorizes the School Business Administrator/Board Secretary to execute said contracts on behalf of the Board, a copy of which shall remain on file in her office which contracts shall incorporate the terms and conditions of the bid specification.
