WHEREAS, the Parsippany-Troy Hills Board of Education (“Board” or “District”) previously entered into a Shared Services Agreement with the Parsippany-Troy Hills Township (“Township”) for the provision of certain School Resource Officers (“SROs”) to work within District schools; and

WHEREAS, the Parties wish to continue and extend the terms of that Agreement through June 30, 2017 or the last day of the scheduled 2016-2017 school year, whichever is earlier; and

WHEREAS, the Parties wish to extend the scope of the Shared Services Agreement to include the provision of additional other SROs and other security services to the Board for the betterment of the students of the District and the citizens of the Township through an Addendum to the Shared Services Agreement; and

WHEREAS, the Parties have the necessary funds and resources available to utilize in the planning, development, staffing and supplying of SROs and such other security services to the Board as set forth in the form attached;

NOW THEREFORE BE IT RESOLVED, that the Parsippany-Troy Hills Board of Education hereby approves the Addendum to the Shared Services Agreement originally entered into on September 24, 2014; and

BE IT FURTHER RESOLVED, that the Board President and Board Secretary are directed to take such action necessary to effectuate the terms of the Agreement.
